HISTORY OF ST. CLAIR CC

Founded in 1909

The year was 1909. The date was August 25th. The certificate of Incorporation signed by James A. Rose, Secretary of State, on this date established St. Clair Country Club as a legal corporation under the laws of the State of Illinois. The application of the state charter was signed by W.E. Trautmann, J. Clark Waddell, R.P. Munger, F.T. Joyner, J.L. Wiggins and L.B. Washburn. The first Board of Directors for the corporation consisted of J.L. Wiggins, R.P. Munger, E.C. Kramer, A.K. Vickers, W.E. Trautmann, Stephen LePage and H.C. Starkel.

It was not until August 16, 1911, that the initial 63 acres of ground were purchased from Judge E.C. Kramer at a cost of \$12,000. A nine-hole golf course was constructed on what basically is now the back nine with the present No. 10 being the first hole.

In 1921 and 1922 most of the ground was purchased for the present front nine and the remaining tracts were bought in 1927, resulting in approximately 170 acres currently owned by the Club.

Membership in St. Clair Country Club increased, and records indicate that there were 200 members by January 1911. In July of that year the membership increased to 300, and in 1982 the membership was further increased to 325 voting members.

The first Clubhouse, built in 1910, was designed by A.B. Frankel, an architect from East St. Louis, and was built by Bergman and Lutz Construction Company at a cost of \$12,000. This Clubhouse served the membership until August of 1964. The second Clubhouse was razed in 2002, when a move was made to the present facilities. The first tennis courts were built in 1920 and the first swimming pool was added in 1947. New all-weather tennis courts were added in 1959, and the Olympic-size pool was completed in May 1969.

In 2013, the members voted to begin a project renovate and restore of the course, directed by Kye Goalby, son of St. Clair member and 1968 Masters Champion, Bob Goalby. The renovation refreshed the course, consistent with the principles of the original architect. It opened to rave reviews in the Spring of 2014 and had the honor of hosting the USGA's US Women's Open Sectional in 2015. The Championship course is currently 6502 yards, par 72. St. Clair CC joined the St. Louis Golf District from 1919-1933, then rejoined after World War II in 1946 and has continued to be a member ever since.

St. Clair CC has been home to a distinguished list of District Champions, such as Bob Goalby (1955), Jay Haas (1972, 1973, 1975), Jerry Haas (1983, 1984, 1985) Mark Boyajian (1981, 1986, 1987) and Tim Riley (2000) for a combined total of 11 District titles.

In 1983 St. Clair CC had three members compete in the Masters Tournament, Bob Goalby, Jay Haas and Frank Connor. Connor owns the rare distinction of competing in the US Open for both golf and tennis. In 1985 Goalby, Jay Haas and Jerry Haas competed in the Masters, the first time in history that three members of the same family were in the tournament in the same year.

While St. Clair CC has a deep history in golf, one of tennis' all-time greats, Jimmy Connors, is also a long-time member of the Club.

Championship Golf Course

St. Clair CC is home to an 18-hole Championship Course, (Par 72, 6502 yards) completed in 1927 and renovated in 2013, and has matured into one of the very finest in the area. At 6502 yards from the Championship tees, the course features five Par 3's and five Par 5's while covering over 170 acres of rolling, wooded hills on the bluff just East of the Mississippi River. St. Clair fairways and tee boxes are Zosia grass with 007 Bentgrass greens. The Par 72 layout is both challenging and enjoyable for golfers of all skill levels.



The Jay Haas Practice Facility, dedicated in 2004, includes a dual-sided driving range, with both grass and matted hitting surfaces, and a short game practice area with a chipping green and practice bunker.

Tennis & Pickleball Courts

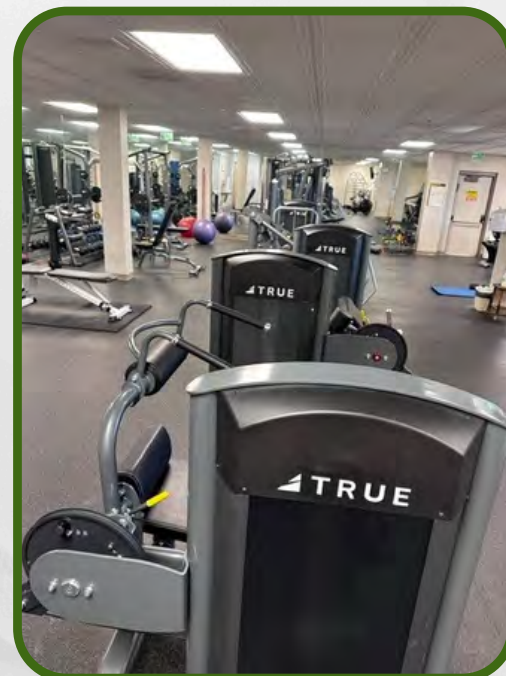
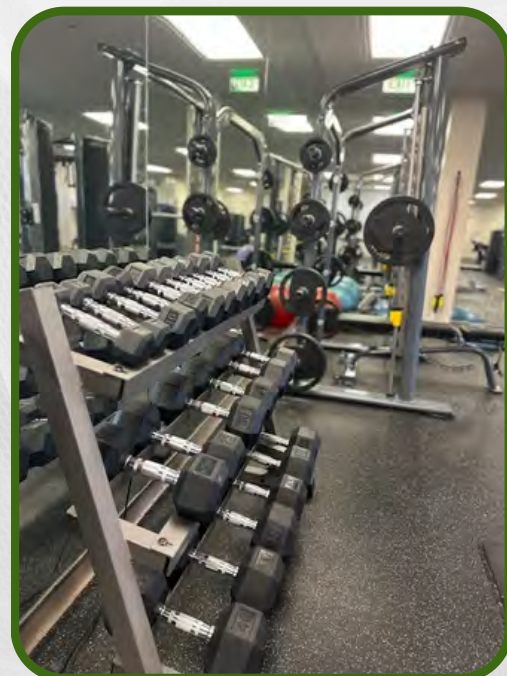
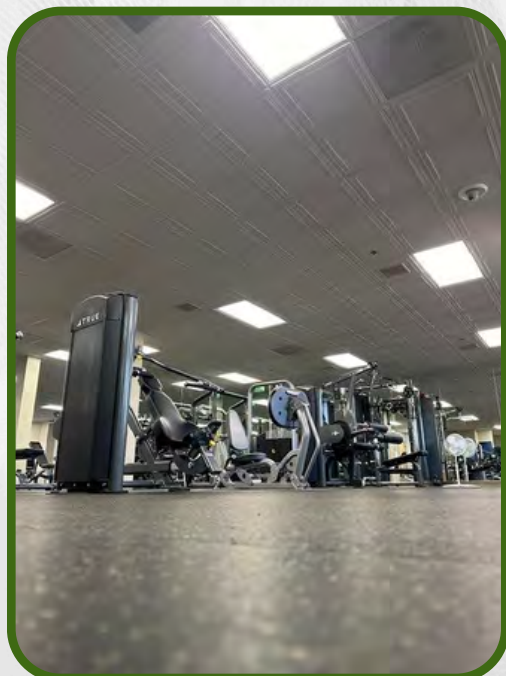
St. Clair Country Club's tennis facility includes three outdoor lighted, clay tennis courts that serve as another venue that brings member's families together.

Fitness Center

Ballrooms

Youth Programs and Lessons

The First Lane Program is designed to teach members as young as three years old to swim and acclimate themselves in the pool. The SCCC Swim Team is the Club's competitive swimmers, competing against other swim clubs in the region.



Youth tennis programs range from Summer camps to individual and group tennis classes (ages 5 and up), and also includes the SCCC Junior Tennis team.



Our professional golf staff holds summer camps, and both group and private lessons for our junior golfers (ages 7-16), including beginner to advanced levels. SCCC also participates in the Junior PGA Tour program, competing against other district clubs.

Membership Prospect Process

St. Clair Country Club is a private membership club. It is owned by those members who have a proprietary interest in the assets of the Club.

Candidates for membership are required to be sponsored and seconded by existing members of the Club and must be approved by the Club's Board of Directors.

Interested prospective members must submit a Membership Application signed by three (3) Sponsors, who are **Active Members of Record**, (and who are **not** currently serving on the Club's Board of Directors), and the application must be submitted to the Club's Office along with the initiation fee, stock fee, (if applicable). Our Membership Director can assist with this, if needed.

The prospective applicant's information will then be posted for a minimum of 15 days and the Board of Directors will consider the individual for membership at their next monthly meeting. If approved the applicant's Club Membership will become active immediately.
